

#### MFMBERS' APPLICATION AND COMMITMENT

I, the undersigned, do hereby apply to become a full member with voting rights of the Cowies Hill Estate and:

- 1. Confirm that I am an owner of and/or resident in the above property and support the Cowies Hill Estate initiative and model as presented to me;
- 2. Agree to become a member of Cowies Hill Estate NPC (2017/179710/08) ("the NPC") and to participate as voting member and abide by the Memorandum of Incorporation of the NPC;
- 3. An initial sign up fee is no longer required.
- 4. Undertake to contribute an amount of <u>R 1,100.00 per month</u>, R200 of which will be allocated to armed response services for my residence, and R900 as a voluntary contribution to the general security, safety, estate management and upliftment work of the NPC;
- And, in relation to point 4 above, I commit to payment of the sum of R 1,100.00 per month for a period of 12 months which will be automatically renewed for a further period of 12 months unless cancelled by me in writing at least 90 days before expiry of any 12-month period. In the case of a sale of my residence, or my ceasing to reside in my residence, I shall provide 90 days written notice to allow for confirmation of signup of purchaser/new resident:
- 6. I accept that after the initial 12-month period the monthly contribution may increase in line with inflation;
- 7. I accept that the NPC has appointed a security service provider, whose terms and conditions of service are attached to this form, and I agree to be bound by such terms and conditions;
- 8. I agree to **sign a debit order**, at the same time as I sign this agreement, in favour of the NPC/ authorized debit order processing company for payment of the monthlycontribution. This debit order instruction will be used for payment if I do not make payment timeously by other means.
- Cowies Hill Estate (NPC) is a member of ACCOUNTABILITY SOLUTIONS (PTY) LTD who assist with the recovery of
  outstanding monies. Once the matter has been handed over to Accountability Solutions, I will be liable for all
  collection costs.
- 10. I understand that the following fees are applicable
  - Cash deposits will attract a 2% cash handling fee to offset additional bank charges.
  - Unsuccessful debit orders will incur an administration fee of R150 per payment.
  - Reminder letters for payment of contributions will in incur an administration fee of R75 per letter.
